Consultation with the public until 7.10pm

Two attended - Resident of Peterborough Road attended to voice his concern at speeding motorists along that road at all times of the day and night. this occurs from The Riva Restaurant and all along- the resident had a near miss recently with a speeding motorist and several neighbours have experienced similar incidents. He would like to see flashing speed signs installed or speed cameras.

The Parish Council did ask that the speed camera from Crowland Road be relocated to here but this didn't happen. Speedwatch can be used by the public to help reduce speed. The next police liaison meeting is on 7th October and any residents form Peterborough Road with such concerns are urged to attend.

Other gentleman pointed out that coming into Eye there are no 40MPH signs – can we get some put up as this may assist in reducing speed.

136) Policing Matters

After the last meeting the clerk received an email from the sergeant voicing concern at how the PCSO was treated and that she hadn't got answers in regard to control and strategy of policing. The clerk replied that questions are often asked from the public as well as members and often the PCSO attending hasn't got the up-to-date crime figures. Suggestion that perhaps it ought to be a more senior officer attending who can answer the questions. Burglary this week of £1,500 fishing gear –property recovered but no arrests made as yet. Door stop milk thefts last week – CCTV coverage of events but no officer has visited one week later.

PCSO Pokun is now the dedicated officer for Eye and Thorney. He does 3 different shifts but does not work between midnight and 8am.

Crime figures this month – 19 crimes, including theft of horse collars, shoplifting at Van Hague, not paying for taxi hire, tools stolen from a van in

Westminster Gardens, credit card theft (culprit apprehended) bench and sign removed from the skate park.

He has had a meeting with officers from Amey and they have said they will have funding within two months for CCTV.

Concern expressed at school age children on the streets during the school day – the clerk will contact the Education Authority.

Biffa had window smashed. Sue Ryder had mobile phone stolen.

72 incidents reported during the month – half of these were calls re anti-social behaviour around Bath Road. Tanholt Farm has had incidents of children playing on the large bales but having matches with them.

He told the meeting he will have another officer to help him to do speed checks down Peterborough Road the week after next.

Members all expressed the view that the police service to Eye is not good enough and nor are the police resources. The clerk will write to the Area Commander and the Police Commissioner to pass on this view.

Report on the Ward Walk on 4th September – Amey are to provide us with a map of areas and frequency that they cut. – 23 years left on their contract.
