It was proposed by Mr Smith, seconded by Mr Short that a £25 deposit should be taken from new allotment holders which is then returned when they give up the allotment but is forfeited if they leave the allotment in an unsatisfactory condition. All agreed. This will be written into the allotment agreement.

97) Transport, Roads and Footpaths

Lee Moore – Temporary Right of Way footpath diversion on Eye footpath no1 which runs alongside the quarry at the end of Toneham Lane for approx 18months.

98) Leeds Hall, Recreation Ground and Amenities

Contractors to undertake Legionella checks on both the Leeds Hall and Pavilion this month.

The guttering is to be put back up on the Pavilion.

99) Community Leadership Fund 2015/2016

This has been replaced by funds obtained under POIS – The Planning Obligations Implementation Scheme and future Community Infrastructure Levy income. There is £1,000 that can be spent in Eye this year from this fund on Neighbourhood Projects but it must be spent on capital projects and not revenue projects.
