Former CLF fund - Letter requesting funds from Eye Primary School to assist with the refurbishment of their swimming pool. £1,000 approved. Councillor Brown will bring the forms to the clerk.

Coun Brown has spoken to Amey re the grass cutting and they are due to commence again in March but will try to do earlier. The grass either side of the church is non-existent where the cable box work has been done.

The new machine is due in Eye which clears up litter etc, even from under parked cars.

Coun Brown attended the meeting where the planning application for the Webbs site was approved. There is to be 1 workshop at the back a small shop and cafeteria with the Co-op at the front. Members surprised at this news as the former Red Lion is to be a Co-op but Coun Brown questioned this and was told they are two different Co-ops. Members still concerned about the workshop. Doubts were expressed that nothing known about ownership of Moores Lane but the Parish Council believe it is jointly owned by 8 High Street residents.

Scheduled walkabout on Tuesday 23rd February at 10am commencing outside 1 Little Close – all Parish Council members are invited. This is organised by Cross Keys – Ward Councillors advise that this is now to take place on 15th March. Much confusion about this – protocol pointed out to Cross Keys by Coun Sanders that the Parish Council members should be invited when in their parish. This meeting now to be held in March.

29) Eye Primary School

Mrs Meadows and Mr Smith went for lunch at the Golden table with the children. Met Mr Webster and were also shown around the school.

30) Cemetery

Quotation for steel arched doors for the Mortuary – will have 1 side that can be opened but other side padlocked and secure. Quote for £1,785 +VAT.

Proposed by Mr Short, seconded by Mrs Magnus that the quote be accepted.

All agreed.

Mr Short will contact local company for a resin plaque for the building to show its history and it was restored in 2016 by Eye Parish Council.

Mrs Meadows expressed concern about some of the memorials on the graves not being “In Keeping”.

All agreed a very difficult area to deal with Mr Jackson was looking into writing to the widow of the grave in the new area who is obviously flouting the rules.

The clerk did remind members that should any articles be removed by the Parish Council they and any articles would not be covered by the Parish Councils insurance.

Mr Duffy will liaise with Mr Jackson and the clerk on a final letter and refunding the payment for the next grave space. Bailiffs could be employed.

31) Allotments

Mr Duffy consulted for advice and there are several options of notice that can be given on the paddock. It was agreed to give the standard 6 months' notice. The City Council website has 35 allotment sites but Eye is not included.

32) Transport, Roads and Footpaths

Judi Anderson, PCC – Proposed 7.5tonne weight limit on B1040 from Thorney to Crowland. Any objections to be made by 29th February. Joint by Peterborough City Council and Lincolnshire County Council.

Pot holes to be refilled in Eyebury Road. Resurfacing to be done in new financial year. The new incinerator will mean move and larger lorry movement.

Lots of flytipping in Green Road – Silver BMW at the end near Whitepost Road and plaster board, tyres, black bags.

Rubbish from the “Red Lion” development was tipped on pavement/dropped kerb at Lukes Lane/Back Lane. Pointed out to them but continued and then pointed out to PCC. Planning passed to Highways and problem was resolved.

33) Leeds Hall, Recreation Ground and Amenities

Ixworth Close – Play equipment removed. Surface not very good. Bench considered but concern that would make a gathering place. No complaints received about the removal. Monitor situation.

The inspection of the play areas did show that the long grass in these areas needed cutting – the contract is to cut 8 times a year but doubt raised that it happens this number of times. The Parish Council can cut extra if it wishes – but would we be reimbursed?

Leeds Hall - the refitting of the toilets now complete – looks good.

The clerk will look further into having the roof redone.

Pavilion inspected last week, fairly good condition. Quotes being obtained for new lounge flooring. Plant room lock changed.

Report – 50 fishing permits have been issued this season

Rubbishing blowing either side of the A47 from the tip reported.

Still vehicles parking on the Edgerly Pond Site. 2/3 benches or bollards would stop this. Clerk to action.
