One present – concerned with the leaflet received in the current Eyescan, has the Parish Council discussed this? Explained that The Local Plan is due to be sent for Consultation on 1st December 2016 – once the Parish Council have received the consultation notice then this will on the agenda of the next meeting for debate.

Chairman and Treasurer from the Peterborough Society of Model Railway Engineers. They are a not for profit organisation, have been operating since the 1960's and run on subscriptions. They are searching for a new home in the Peterborough Area as Thorpe Hall needed the land for expansion. They use 2 tracks that wrap around each other. They are very interested in the land north of the A47 which includes our former paddock and allotment area and have been in talks with the Church Commissioners. They would need a long lease and planning permission and would be required and would need secure storage – usually smart shipping containers. they would also need a generator but the actual track couldn't be secured. They expect to take 5/7 years to complete the project. They are open to the public at times to increase their income stream. There would be sufficient off road parking and light catering facilities on the site. They would expect increased traffic flow on certain days and times and expect some objections but there would be benefits to Eye and they hope for local support and encouragement for the project.

The Parish Council are in favour of the proposal and the clerk will invwstigate the exact areas and report back.
