Peterborough Local Plan for Consultation – comments by 9<sup>th</sup> February

The Parish Council object to the proposed 250 new houses for Eye. There is no increase planned for the infrastructure - roads, school, drain, water etc and all are at capacity. These must all be improved before any further houses are built.

The clerk is to ensure that all the green spaces in the village are included in the local Plan – ie Near the Spinney, Bath Road, rear of the Community Centre, school playing field. Lindisfarne Recreation Ground.

## **10) Eye Primary School**

Improvement work to commence soon on the swimming pool.

The school has 400 on roll – capacity is 420.

Only one further plot to comply with rules – further letter sent.

Request made for a bench – denied.

## **12) Allotments**

Meeting held with Savills and Peterborough Model Railway Engineers. They wish to relocate on the Hodney Site using Church Commissioners Land, some of which we rent from the Church Commissioners. One field we were not aware we were the tenant of! The proposal is to just use three strips at the far end for allotments, sub-let the remainder to the Peterborough Model Railway engineers and return the rest to the Church Commissioners to be turned back into arable use. A new gateway to be created for our allotments.

This was proposed by Mr Goodsell, seconded by Mrs Meadows. All agreed

The clerk will check if there will be any costs to the council.

The triangular piece of land nearby with a new gateway is believed to be owned by PCC – map to be sent to Coun Allen to investigate.
