The Co-operative Group – letter notifying the Parish Council that they intend to open a new Co-op Funeral care Centre at the former Webbs site in the High Street. A full planning application is to be submitted shortly

Unfortunately, the items that were agreed to be removed have all been put back apart from the kerbing. It was agreed to remove all the unauthorised items as well as send a refund and revoke the next space burial rights.

Green Road site is full with a waiting list. A problem has arisen with parking areas being used for sheds etc causing issues. Mr Smart will look at.
