1) Declaration of Interests

2) Items for City Councillors -

Letter from Julia Brown Bath Road Residents Group applying for funding to install warning signs to slow down or a flashing reduce speed sign for Bath Road. The roads are narrow, some very tight bends and some properties have no driveway. Some use it as speed track. Such measures would make the estate safer for all. The Ward Councillors are currently spending their CLF allocation on speed warning signs for Thorney Road and next year with the help of the Parish Council hope to get speed signs for Peterborough Road. Coun Allen will respond to Ms Brown. The sped warning signs have been approved and will be erected in March.

Speedwatch – Mrs Magnus has received the training and two more people required. Concern from Paul, the co-ordinator that the equipment is being spread too thinly and perhaps parishes could share. Cost approx. $\pounds1500$ and Newborough Parish has indicated they would be willing to share with Eye.

Coun Allen will ask the co-ordinator to attend our next meeting.

The PCC Scrutiny Committee have agreed to proceed with the asset transfer by the end of March of community centres which includes the one in Eye. Original there wasn't any time limit. The Parish Council have met with the Community Centre committee and have received their accounts. Unfortunately, the PCC Officer has been asked for information but detailed information has not been received. The clerk will request the information and copy in Coun Allen.

There is a new planning application adjacent to the Nature Reserve and this increases the proposed number of hoses to be built – originally this was 35, increased to 55 and is now 67. This appears to be a very overdevelopment of the site. The open space areas are just small areas that cannot be built on and the area near the "pond" at the footbridge is part of the Nature Reserve. The Parish Council therefore dispute the boundary. The clerk will ask the planning officer to visit us to discuss this. Nothing has been heard from Bill Greens family concerning a bench in his memory being placed at the Nature Reserve.

10) Allotments- Report


Green Road allotments – no issues.

11) Eye Primary School

Results for the Peterborough area have just been published – Eye Primary have done very well. The clerk to write congratulating the school on their results. The school currently has 417 children on roll, the capacity is 120.

89 applicants for the new Foundation intake in September. This does include $2^{nd} \& 3^{rd}$ choice schools and there is only space for 60 children. The main criteria involves living in the catchment area, looked after and statemented children and siblings already at the school.



Email from Alison Escott, Office Manager – they are updating their swimming pool for community use and have been advised that it would be beneficial to have a Defibrillator fitted in case of an emergency, costing between £700-£1,000. Asking if there is any local funding that could assist with the purchase of this. It was proposed by Mr Holmes, seconded by Mr Smart that the Parish Council provide the funding for this defibrillator. All agreed.

Letter received from Judi Anderson, PCC advising that she has sent out 48 letters concerning parking restrictions in Northam Close. Only 1 reply was in support, 5 opposed the proposal and she is therefore taking no further action. The clerk to find out if the Community Pay Back Workers be utilised to pull out the litter from the dykes in the area so that Amey can collect it. The drains around the McDonalds roundabout have all sunk.
