## Minutes of a meeting of Eye Parish Council in the Leeds Hall, High Street, Eye on Thursday 16th August 2018 at 7.00pm

#### **Larkfleet Homes**

Representative for Larkfleet came to report on their exhibition held at Eye Primary School on their proposed new development in Eyebury Road. Well attended – over 140 people. The main issues are with access and transport. A further traffic survey is to be done in September. Discussions continue with PCC planning reviewing the feedback. Will be working with Highways Full application to be submitted at the end of September.

Concerns raised by members that the infrastructure of the village needs looking at before any further developments occur. Eyebury Road is not a full 2way road all the way through and this development of more than 200 houses will make the roads in Eye gridlocked.

The Ward Councillors are all opposed to this development.

Several members of the public expressed their disappointment that the current Larkfleet development along Thorney Road has still not had the roads or open space completed and faults with the houses have yet to be resolved – 2 years after occupation. Response to their complaints by phone or email is poor. Another issue pointed out is the Larkfleet Community Fund where funds from developments used for community groups in the village. Several groups were successful but after months of waiting the Church Group were refused funds for repairs to the church clock.

Baltic Motorcross Club are looking for a new venue and wonder if the Hodney Road allotment site would be available. This will be on next month's agenda.
