Still problems with gravel from the quarry being spilled over the roundabout on the A47. Clerk to inform the quarry.

Mrs Parker from the Model Railway Engineers told the meeting that the Society are trying to arrange a meeting with the planning department to discuss their application as issues with both the Ecological assessment, Archaeological survey and they have also been told that the application takes up the allotment requirement needed for Eye under the allotment act – the clerk will check this with our Local Association.
