**20) Items for City Councillors**

The “pipe” at the skate park is to be upgraded.

Bollards being investigated along Eyebury Road and around the corner near the school. Approx 70 bollards needed.

Village Litter Pick on 23rd March commencing at 11am at the Manor Farm Community Centre – part of the Great British Spring Clean.

Litter pickers and bags provided – refreshments at the Community Centre.

Larkfleet have completed the road and footpaths and have put the play equipment in. It is unusable at the moment though as the ground has been churned up.

The newly created footpath at the side of Fountains Place has been left with a steep slope and there is a spare piece of land which has been left.

The condition of the path & cycleway at the Community Centre is still in a poor condition.

The Tesco Distribution Centre had a problem last week which has been addressed.

A47 has been litter picked right up to Crowland Road – was PCC responsibility and not Highways England.

Nothing heard from Planning re the Model Railway Application.

REF:18/02196/MMFUL & 18/02185/WCMM Dewatering of waterbody and infill with approx. 375,000 cubic meters of construction, demolition and excavation waste with restoration to grassland and a new surface water management system.

Judi Anderson, PCC – Letter received advising that a consultation took place in 2014 regarding the introduction of double yellow lines in Whitby Avenue and Millport Drive, many objections were received but it was then agreed to place double yellow lines at the junction of Millport Drive and Whitby Avenue. These lines have never been marked out but will be shortly.

Judi Anderson, PCC – The City Council are proposing to introduce a 7.5T weight restriction (except for loading) along the full length of Peterborough Road, Eye between the roundabout at its junction with Frank Perkins Parkway and the roundabout at its junction with the A47 Trunk Road. Comments by 28.2.2019.
