96) Items for City Councillors

The Keep Left signs at the church roundabout are to be replaced with a more robust type. Replacement waste bin outside the Leeds Hall now fitted.

Bollards with the contractors for installation.

Bar Pastures Farm Quarry visited – Looking very neat and tidy

Pode Hole Quarry also visited – proposal now is for the other side of the road at Willow Hall.

The cycleway/footpath through to Thorney isn't being done – this is to be debated at PCC Full Council.

Grass Cutting Schedule at Community Centre needs looking into as the grass is high. The east entrance to Fountains Place is very overgrown and needs attention.

Coun Allen has a meeting tomorrow at the Nature Reserve.

Speeding along Thorney Road continues to be an issue – Enforcement action to be deployed. Speed watch regularly operates throughout the village.

Peterborough Road Car Sales are regularly parking vehicles on the footpath – blocking it for pedestrian/mobility/wheelchair users - meaning that people have to go into the road to get past. Coun Brown has visited to offer advice. Vehicles details causing future problems to be passed to PCC and the PCSO for enforcement action.

97) Letter from Peterborough Society of Model Engineers Ltd

They have applied for planning permission and are still are waiting to hear. The City Council Planners have indicated to the Model Railway that the use of the allotments may be a problem – no contact has been made from the planning department to the Parish Council to discuss this issue. Coun Allen is chasing this up. The site still has worked allotments on them and will continue to do so and the Parish Council do have another allotment site in Eye Green. The Parish Council have been unable to confirm the length of the lease, whether it will be renewable or what the new costs will be to the Parish despite numerous emails between the Parish Solicitors and the agents for the Church Commissioners who own the land. An Ecological survey is required which will cost £1100 plus and the Model Railway need assurances that the project is possible before they commit to spend this moneyThe Parish Council continue to be fully supportive of this group and their plans for the Hodney site.
