### **211) Items for City Councillors**

Map of the overgrown areas around Fountains Place passed to the City Councillors Police & Crime Commissioner attending the January meeting.

The bollards at Little Close to be resurrected and Eyebury Road area is being investigated again. How far they need to go and will they be effective and make a difference? Residents have said they don't want them but current parking restrictions appear to be insufficient and appear to be needed on the corner. This could be a joint venture between the Parish Council and the Ward Councillors using the CLF money.

### **212) Peterborough Model Railway**

Discussion with the planning officer as to alternative allotment site. The Parish Council do not have any other land.

Meeting held with the Church Commissioners to clarify the position with the land at the allotment site. The 2 options being –

1. To give up the 2 areas of land currently tenanted and then a 20year lease will be granted to us for the Model Railway.
2. Not to surrender any land which means the 20 year lease to the Model Railway will not be granted.

Option 2 was proposed by Mrs Meadows, seconded by Mr Smart.

Unanimously agreed.
