Parking issue - Peterborough Road

The garage there that sells cars is parking the vehicles everywhere including on the green pond site which is owned by the Parish Council and making it very difficult for nearby residents to park. Parking Services at the City Council are aware. Clerk to write to the owners.

Councillor Brown reported that there are 8 caravans parked at Loves Land, Crowland Road which the City Council are looking into.

Another revised application has been made for the proposed Larkfleet Development. Our original objections still stand. The clerk will check with the planning officer whether the objects have to be put in again as we are not sure and many members of the public aren't sure either.

Councillor Brown has objected to the development.

Concerns as to where the S106 monies from such developments have been spent in recent years.

Request that all current yellow lines be reinstated clearly. Still issues down Eyebury Road/New Road.

Brown Bins to be left out until emptied.

Request for a dual rubbish/dog bin along Hodney Road/Green Road/Woolfell Hill Road. None there and it is a well-used dog walking route.
