Report of meeting with allotment holders

15 allotment holders attended and 5 Parish Councillors. General matters discussed concerning the upcoming growing season.

Discussion concerning bonfires as there has been several complaints about bonfires. Not all do have bonfires but there are some weeds that can only be destroyed by burning – hence the need for bonfires.

A comprise was agreed and members voted unanimously that that bonfires would only be allowed from 29th October -when British Summer Time ends to the 1st April when British Summer Time begins. There are several allotment sites in the area that do this and they tell us it works well. The other rules for allotment burning will remain. The Parish Council will provide a skip during the summer months for rubbish to be removed.

New combination to go on the gate lock

The committee visited the site yesterday and reported that 2 plots are vacant, 10 have been prepped for the new growing season with 9 having not been worked so far.
