Consultation with the public – 12 present

Loss of the School Crossing Patrol – several residents attended to express their concern that this service is being withdrawn at the end of the school year. Concern for the safety of the children and the community. The crossing patrol has been in place for a number of years. There are plan for a pedestrian crossing but no date for when this will happen. The residents are to do a petition to keep the Crossing Patrol until the crossing is in place. The Parish Council fully support the residents and are disappointed that yet again another important facility is being withdrawn in the village with no infrastructure improvements despite S106/CIL funds generated by housing developments.

Both Ward Councillors Allen and Ormston present told the meeting that they have funded the crossing patrol from their councillor budgets until July and are working with City Council Officers on this issue.

Peterborough Rangers Football Club – members of the team apologised for the state of the changing room left by their opponents. Made clear that the Lindisfarne Road site is an Open Space and a Recreation Ground – not a football field, and is for the use of all Eye villagers.

Parish Council members will discuss further at the end of the meeting in closed session and the club will be notified on Monday as to whether they will be permitted to play there next season.

The Parish Council have concerns with this application as the building is in a Conservation Area and previous applications submitted had work undertaken without consent from the Planning Authority.

We would like to see the building be restored to its original state and to the satisfaction of the City Council Conservation Officer. The Parish Council have concerns that isn't enough parking on the site for staff and for cars/taxis/minibuses collecting/dropping off the children for school etc. The road at the front of the property is very busy and close to a busy junction and is not suitable to park vehicles safely. We also have concerns that the premises will be operational and the effect on neighbouring properties. There is still a very large rubbish heap at the rear of the building which needs urgently removing.
