# 1. Community engagement


# 1.1 Open consultation – November 2022

The initial consultation with the villagers of Eye and Eye Green took place on 19th and 20th November 2022. Open days were held at the Leeds Hall and villagers were invited to attend and share their opinions on different aspects of village life under predetermined headings. They were able to write their thoughts regarding that topic on post-it notes which were then collated.

The event was advertised in the village magazine and on the Eye community Facebook group.

Twenty-two residents attended the Saturday open day, and 13 attended on Sunday.






## 1.3 Detailed survey – July to September 2024

A detailed survey was made available to villagers in paper and online format. Questions were asked in the following categories:

- Housing
- Transport
- Services, amenities and facilities
- · Community, sustainability and environment
- Heritage and archaeology
- Employment



It was promoted on the village website, in the village magazine, leaflets and displays in local buildings, and on the village community Facebook page. Examples of the promotion are shown below.







174 responses to the survey were received. The responses are available in Appendix 1.

# 1.4 Eye Summer Fair – 6th July 2024

Members of the steering group attended the village summer fair in July 2024 where they spoke to villagers about the Neighbourhood Plan and gave out copies of the survey. This was considered to be the best opportunity for an in-person event as it was well-publicised and was expected to attract a large crowd of local people. It was well attended and was a very positive experience. Awareness of the Neighbourhood Plan project was raised and villagers were encouraged to get involved in its development.





# 1.5 Draft Neighbourhood Plan consultation – May to July 2025

The draft Neighbourhood Plan was made available for review on  $10^{th}$  May 2025, with the consultation period closing on  $20^{th}$  July.

A prominent advertisement was placed in the village magazine, and it was promoted on the parish website and the village community Facebook page. All publicity stated that the paper copies of the draft plan could

be picked up from the Leeds Hall, Manor Farm Community Centre, the library, and the café. An online version was made available via the parish website, links to which were included in promotion on the village community Facebook page and in an advert in the village magazine.



The paper and online copies stated that comments could be submitted in writing, via email or via an online form. Comments were received from villagers and from the Church Commissioners. The comments are detailed in Appendix 2.

# 1.6 Eye Summer Fair – 12th July 2025

Part of the community consultation was the attendance by members of the steering group at the village summer fair in July 2025. This was considered to be the best opportunity for an in-person event as it was well-publicised and was expected to attract a large crowd of local people. This proved to be the case and the team spent several hours talking to villagers about the Neighbourhood Plan and giving out draft copies. There was a high level of engagement from local people who were keen to find out more about the draft plan and take a copy away.





# 2. Peer review of draft Neighbourhood Plan

Before the draft Neighbourhood Plan was shared with the village, and as part of the commitment to engaging with the community, it was reviewed by two villagers who were invited to provide independent feedback. They were asked to identify any omissions, assess the clarity and coherence of the document, flag potential duplication or conflicts between policies, and offer their overall opinion of the plan.

These reviewers assessed whether the plan was understandable to the general reader and would therefore be accessible to the wider community. It was important for the steering group to be seen to be collaborating with villagers at every stage of the process, and we appreciated fresh eyes assessing the policies and their relevance to the village. The reviewers provided useful feedback which then fed into the production of the draft plan that was put out to consultation.

# 3. Community consultation - Issues raised

Details of the comments received are available in Appendix 2 and are summarised below.

### 3.1 Village infrastructure

Respondents commented that no further housing should be imposed on the village without improving the existing infrastructure. They noted that the school and health services (doctor/dentist) are oversubscribed and there were concerns about the impact on these of an increased population.

This concern is addressed in policies HS1 and HW5.

# 3.2 Protecting the character of the village and the green wedge

There were concerns raised about the village losing its character and becoming subsumed into greater Peterborough. Respondents wanted to protect the green wedge and ensure that the area remains a village.

This concern is addressed in policies VC2, VC3, EN1, EN3, and EN4.

# 3.3 Housing

Most respondents raised concerns about the amount of additional housing the village has already absorbed in recent years. There were concerns about the types of housing that may be built, with some respondents commenting that new starter homes were particularly required.

This concern is addressed in policy HS2.

There were also concerns raised about the impact of additional homes as they may exacerbate existing issues with drainage and sewerage in particular parts of the village. The fact that much of the Neighbourhood Plan area is low-lying and considered to be floodplain was also raised as an issue regarding where additional homes may be sited.

The topography of the Neighbourhood Plan area is covered in section 2 of the plan. The topography of the Neighbourhood Plan area is covered in section 2 of the plan. Existing planning regulations prevent building on flood risk areas.

### 3.4 Traffic

The volume, speed and safety of traffic on Eyebury Road, particularly by the school, was raised as a concern. As noted in the plan, this is one of the arterial roads into and out of the village but is also a single-track road with passing places. Developments that are already planned for the village and neighbouring areas are expected to increase the traffic on this road which already suffers congestion. It was also noted that the congestion on this road negatively impacts the air quality at the school.

Speeding and volume of traffic in general throughout the village were raised as concerns.

These concerns are addressed in policies TR1, TR2, TR4, and HW1.

# 6. Developing the plan - External consultations

## 6.1 Peterborough City Council

Throughout the development of the Neighbourhood Plan, the steering group has actively engaged with planning officers at Peterborough City Council to ensure the plan is both robust and compliant with statutory requirements. These consultations have provided the group with a clearer understanding of the legal framework governing neighbourhood planning, including policies set out in the National Planning Policy Framework (NPPF) and the Local Plan.

Drawing on the professional expertise of the planning officers, has helped the steering group to refine the scope and content of the plan. This collaborative approach has also enabled the group to anticipate potential challenges and proactively address them, ensuring that the plan aligns with broader strategic objectives and planning principles.

This collaboration has strengthened the quality and credibility of the Neighbourhood Plan. It reflects a shared commitment to producing a document that not only captures the aspirations of the local community but also meets the legal threshold required for formal adoption and implementation.

Planning officers attended the steering group meeting held on 11<sup>th</sup> June 2024. This was an opportunity for us to understand what we should be covering in the plan, and to clarify the process of getting it adopted. The draft plan was then submitted to them in February 2025 for their review and input. Their feedback was extremely useful, and changes were made to the plan, where appropriate.

### 6.2 Cambridgeshire ACRE

Cambridgeshire ACRE is a charity that supports rural communities across Cambridgeshire in addressing local housing needs, often through the delivery of small-scale affordable housing schemes. As part of the Neighbourhood Plan development process, a representative from the charity attended a steering group meeting and provided a presentation on the use of 'rural exception site' planning regulations.


The presentation clarified how rural exception sites can be used to deliver affordable homes specifically for people with a local connection. The representative outlined the legal framework, eligibility criteria, and partnership models that make such developments viable, including collaboration with housing associations and landowners.

By engaging directly with Cambridgeshire ACRE, the steering group gained practical insights into policy implementation, strengthened its evidence base, and opened up a pathway for future collaboration.



Q1. New housing in the village should be limited in number in order to respect the village character. 172 responses




Q2. All developments in the village, commercial and residential, should provide adequate off-street parking.




# Q3. What type of housing do you think is most needed in the village? 165 responses






Q6A. Do you use any other methods of transport to reach your school, college, or work?


Q7. How many days per week on average do you commute to school, college, or work? 97 responses




Q9. Are you concerned about speeding in the village? 171 responses




Q10. How far do you agree with the statement that all new developments should be designed to reduce opportunities for speeding.










Q15. In the last two years do you think that the following aspects of living in the village have got better or worse:




Q16. To what extent do you agree with the statement: 'the streets and public spaces in the village offer a safe environment?'




Q17. How satisfied are you with the parks, play areas, nature reserves, and other green spaces in the village?



Q19. Should the Neighbourhood Plan aim to promote the following? 167 responses





Q21. How important is it to you that the historical features of the village are protected? 171 responses




Q22. Do you work in the village (a workplace other than your home)? 166 responses




Q23. Do you ever work from home? 164 responses

# **Appendix 2: Responses to draft Neighbourhood Plan consultation**

I understand the need for more housing but are they going to be within the price range for lower income starters. Our young adults are going to be pushed out of their home village. I do not agree with building more houses until the village infrastructure has seen some investment. Our school doesn't have room for everyone who needs a place, there is a waiting list for the NHS dentist in the village. The doctors' surgery are overworked and it is a battle to get an appointment. Eyebury Road traffic is already a dangerous nightmare without adding more vehicles. I'm concerned about the air quality in the school playground due to the heavy slow moving traffic. The scandal of losing the school crossing lollipop officer is beyond belief and our children's health and safety will be put at even greater risk with more housing meaning more traffic. I'm worried that any industrial development in the green wedge between Eye and Parnwell will mean that there will be creeping development until Eye loses its identity as a village.

2.6 Current developments close to the village

There are two large-scale developments underway close to the village:

### Oxney Road

22/01345/OUT: A light industrial development of 22,000 sqm to the south of the village. Eyebury Road, the single-track road leading out of Eye, is a main access road to this development site. The construction work and subsequent businesses are likely to increase traffic using this road.

Manor Drive/Roman Fields

16/01197/REM: A development of 457 dwellings together with associated access, highways, parking and landscaping to the west of the village.

Other larger scale future developments in the planning process within one mile of the parish.

Flagship Park (18/00080/OUT) - 127 acre site with a range of industrial accommodation (B1/B2/B8), from 20,000 sq ft to over 650,000 sq ft to the south of the village (five phases).

P24/01538/REM: Phase 1: Erection of a new building for B2/B8 uses with ancillary office space, internal access road, parking and yard space, ancillary buildings including gatehouse, hard and soft landscaping, attenuation ponds and swales associated

Staplee Way, Parnwell 25/00216/FUL: Proposed industrial/distribution development (Use Classes B2/B8) including ancillary offices together with parking, servicing, hard and soft landscaping, and associated works and infrastructure Norwood development (2000 homes and associated infrastructure) adjacent to the parish to the to the west of the village.

23/00483/OUT: Development of a phased residential development (up to 1,130 dwellings) including green space, access and other associated infrastructure.

19/00272/OUT: Outline application for the erection of up to 870 residential dwellings with access from Newborough Road; provision of a primary school and playing field; a local centre up to 0.25ha with A1/A2/A3/A4/A5/D1 use classes; open space and landscaping; and other infrastructure. Thanks

As a resident of Eye for over 20 years, I have seen the huge amount of housing that has already been built, and the effect this building has had on the village infrastructure. Eye has done it's bit for the area and it's now time for other villages to take on some of the burden. Eye needs to retain the little bit of village feel it has left, time and money needs to be spent improving what we have now, before it's too late. Eyebury road traffic calming needs re looking at. During rush hours, Eyebury road becomes grid locked, due to the poorly designed traffic calming and becomes a race track when not so busy. General speeding throughout the village is a growing problem, as the population increases. As mentioned in every survey, consultation etc that is completed in Eye, the surgery and dentist are totally unsuitable for the size on the current population.

Excellent Plan! But...whist I agree that housing is required, particularly for our young people, Eye village is not the place for it. In-fill sites are acceptable but how would our medical centre cope with an influx - it can't cope now! My request for an appointment resulted in a booking for a phone call in 6 weeks time. Traffic in the village has already seen a huge increase, particularly in Eyebury Road and at times around the school. How will that road cope with maybe 400 cars leaving the approved housing estate behind the school??....the most narrow road in Eye. I believe the local school is now full, it is difficult to register with Eye dental care, despite an additional dentist. We really are in danger of losing our status as a Village and in future I imagine Eye becoming a suburb of Peterborough. As mentioned in the Plan, the road out of Eye towards Blue Diamond needs to have a weight limit imposed NOW as great numbers of HGV's are using it without any restrictions. And what about our Green Belt. Good luck

Further to my previous email regarding the Plan, I do have more concerns... When I moved to the Thorney Road area, insurance on my property was initially refused untill I contacted further insurance companies. The reason given was 'the property has been built on a floodplain' However further construction has been granted in this area! What does this say for further development in our village, plus drainage and sewers could be overwhelmed?

We have lived in Eye for 20 years and seen the various problems increase over these years the over subscribed School GP surgery and dentist. The traffic problems have got a lot worse and the drainage problem in Lindisfarne Road is a nightmare when we have heavy rain the drains fill up and overflow and toilet bowl fills up and cannot be used Unless better infrastructure is planed this problem will only get worse with adding all the proposed new development

As it is referred to it may be useful to add Para 73A

 Para 74 Neighbourhood planning groups should also give particular consideration to the opportunities for allocating small and medium-sized sites (of a size consistent with paragraph 73a) suitable for housing in their area.




