Concern from a member of the public that gravel from driveways in the High Street is coming out onto the pavement, not being swept back by residents and is causing problems for pedestrians especially for mobility scooters, wheelchairs and prams/pushchairs. 147) Items for City Councillors

Report of Public Meeting held on Fly-tipping on 7th August. The City Councillors are to have a follow-up (wash-up) meeting with Council Officers to discuss the points raised and the way forward. A lot of Fly-tipping isn't accurately recorded if it is on private land. It is hoped to be able to engage with the landowners and to collect the fly-tipping. There is a working group that meets fortnightly to deal with the issue. Thanks to the City Councillors for organising the meeting.

Coun Allen reported that the Ward Councillors have had a meeting with a company wanting to build a Care Home in Green Road, Eye. They suggested that an entrance would be better from the McDonalds site as previous issues were that Green Road is a single track road. The company now want a meeting with the Parish Council and the City Council planners prior to a planning application being made. The clerk has been contacted and will try to arrange this.

100 High Street has a planning application for change of use to assisted living. This is where residents live independently but with assistance. The property is privately owned by a Charity.

Ward Councillors have had a zoon meeting with 3 doctors from the

Eye/Thorney/Whittlesey Doctors practice. They would consider an alternative larger location and are well aware of the expansion of the village and surrounding area but a new site would need to large enough and approved by the Integrated Care Board etc, with adequate funding available.

The old chip shop site in the High Street is one possibility.

PE1 5YG Concern that this proposal would generate more traffic in the area and more vehicles would use the already congested Eyebury Road going past Eye Primary School REF:25/00216/FUL Proposed industrial/distribution development (use Classes B2/B8) including ancillary offices together with parking, servicing, hard and soft landscaping, & associated works and infrastructure at Land at Staples Way, Parnwell Concerns re the height of the proposed buildings and the effect on the nearby Oxney Grange development and its residents.

The Parish Council want to ensure that there is ample parking on site for staff, visitors and vehicles transporting the residents to school and that vehicles can turn round and don't have to reverve out onto the road. No vehicles from the property should park on the pavement or road in front of the property at all as the road is very close to the nearby mini-roundabout which is busy especially at school times with both traffic and pedestrians on the school run.

Eye Parish Council wish to ensure that the property complies with the requirements of the Conservation Area and satisfies the Conservation Officer.
