165) Items for City Councillors

Report from Coun Ormston (not in attendance) – Eyebury Road development, there must be a left turn for access, reduced delivery times and concern that there is lack of space for workers car parking.

He has reported back at his and the Parish Councils disappointment of lack of notice and advertising for the recent police surgery held at the Manor Community Centre. Email received from resident of Castle Acre concerning obstructive parking etc. Councillor Allen has visited the area before the meeting and will report the matter to Cross Keys and Coun Ormston has reported the matter to Planning Enforcement for investigation.

Coun Allen has had a complaint from a resident in Lindisfarne Road. Their property backs on to the compound at the rear of the Pavilion, which is Parish Council owned, and they require access to cut their hedge. The clerk has advised them that access cannot be given all the time because of Health & Safety concerns but the Pavilion caretaker/landscaper will let them know when he is working on the site and they can access their hedge at that time.

The application was withdrawn and they are to resubmit an application with additional supporting documents within 28 days. If not formal planning enforcement action will be considered.

Informal meeting held re proposed 70 bed Care Home, Green Road with the Parish Chairman, The Parish Vice-Chairman and Mr Iain Forsyth for the developers. Concerns of lighting, asbestos on the site and the road, footpath and lighting would need improving. Planning application awaited.

The War Graves Commission have given permission and guidance for a local stonemason to clean the two graves in the cemetery. His quote is awaited. Concern from Mr Smith that there are large tree branches overhanging neighbouring properties. One quote received from a professional arborist to assess all the cemetery trees, more will be sought. Brambles will be cut back by the landscaper.
