The Parish Council Object – the building may have asbestos, concern with vehicle movements with the 7.5tonne limit on the road and the road to Masons Bridge is in a very poor state and further heavy vehicle movement will only exuberate this.

REF:25/01376/HHFUL Loft conversion with dormer windows at 34 Lindisfarne Road, PE6 7XH. No comment.

REF;25/01293/FUL Installation of metal roller shutter – (retrospective) at 53 High Street, Eye, PE6 7UX. Object as in Conservation Area so should be inside the premises.
